Is Egypt's first hybrid solar-plus-battery project?

Norwegian developer Scatec ASAhas signed a 25-year power purchase agreement (PPA) for a 1 GW solar array and 100 MW/200 MWh battery storage project in Egypt. CEO Terje Pilskog says it is Egypt's first hybrid solar-plus-battery project.

Where is octopus' ardandra storage & solar project located?

That is, the projects will sit in Queensland's south, just under 400 km west of Brisbane. "When constructed in 2025, Ardandra in combination with Dulacca will create the 'Western Downs Energy Park,'" Octopus Australia says, though it is not clear whether 2025 will mark the beginning of construction or the project's completion.

Notably, the single largest among generation projects under construction is Ardandra Storage and Solar in Queensland, which is a hybrid combining 175MW of solar PV with 400MWh battery storage. CEC chief executive Kane Thornton said barriers to large-scale renewables remain due to "the historic lack of leadership, planning and foresight over ...
