

Who are the British Virgin Islanders?

British Virgin Islanders are British Overseas Territories citizens and since 2002, are also British citizens. The islands were named "Santa Ursula y las Once Mil Virgenes" by Christopher Columbus in 1493 after the legend of Saint Ursula and the 11,000 virgins. The name was later shortened to "the Virgin Islands".

How big are the British Virgin Islands?

The British Virgin Islands comprise around 60 tropical Caribbean islands, ranging in size from the largest, Tortola, being 20 km (12 mi) long and 5 km (3 mi) wide, to tiny uninhabited islets, altogether about 150 square kilometres (58 square miles) in extent.

How many islands are in the British Virgin Islands?

The British Virgin Islands consist of the main islands of Tortola, Virgin Gorda, Anegada and Jost Van Dyke, along with more than 50 other smaller islands and cays. About 16 of the islands are inhabited. The capital, Road Town, is on Tortola, the largest island, which is about 20 km (12 mi) long and 5 km (3 mi) wide.

Is the British Virgin Islands a member of CSME?

As of 2 July 1991, the British Virgin Islands holds Associate Member status in CARICOM, the Caribbean Single Market and Economy (CSME).

Where are the British Virgin Islands located?

The islands are geographically part of the Virgin Islands archipelago and are located in the Leeward Islands of the Lesser Antilles and part of the West Indies. The British Virgin Islands consist of the main islands of Tortola, Virgin Gorda, Anegada and Jost Van Dyke, along with more than 50 other smaller islands and cays.
