Large energy companies have expressed that there are no Power Purchasing Agreements (PPAs) available specifically for stand-alone storage projects, making it harder to finance those projects.

Colombia's first BESS tender was aimed at finding an investor to design, build, operate and maintain a battery in the department of Atlantico. UK-based Habitat Energy has expanded into the US power market with plans to optimise a portfolio of 60MW of battery energy storage system (BESS) assets.
