### Do microgrids need Smart Grid technology?

To offer those services, microgrids need to be equipped with smart grid technologies, which allow a two-way flow of both data and electricity between the microgrid and the main electricity network, but which also facilitate the management of the microgrid itself (I-scoop, 2022).

#### Can microgrids be integrated into the energy system?

To better integrate microgrids into the U.S. energy system, Federal Energy Regulatory Commission (FERC) issued new regulations in 2020 that require utility companies to allow microgrids to provide energy to the grid just like any larger power plant.

The term "microgrid" refers to the concept of a small number of DERs connected to a single power subsystem. DERs include both renewable and /or conventional resources. #### Can microgrids be regulated?

If the existing rules in EU energy law allow for some flexibility to include electricity household consumers under the provisions of Closed Distribution Systems and allow for Citizens Energy Communities to manage part of the distribution system, the legal framework does offer possibilities to regulate microgrids.
