What does the MoD's £155 million contract mean for Gibraltar?

The £155 million contract, which will provide maintenance work, repairs, servicing, and hard facilities management to the MOD's estate in Gibraltar, has been awarded to Mitie by the Defence Infrastructure Organisation. It is expected to directly sustain around 200 jobs in Gibraltar.

How does Gibraltar Mine work?

The Gibraltar Mine's processing facilities have two separate bulk sulphide concentrators, a dedicated molybdenum flotation plant, and multiple oxide leach dumps to feed a solvent extraction and electrowinning (SX/EW) facility. The ROM ore is fed into the two sulphide concentrators, which have a combined design rate of 85,000 tonnes per day.

How was geotechnical information entered at Gibraltar Mine?
