#### Can a tenant install a solar panel?

### Are solar panels legal?

#### Do I need permission to install solar panels?

Nevertheless, if your building is listed or located in a conservation area, you will need to seek specific permissions. It's paramount that any solar panel installation is carried out by the Microgeneration Certification Scheme (MCS).

#### Can solar panels be installed on a listed home?

To install solar panels on a listed home, you must apply for a Listed Building Consent(LBC) from the LPA. For your LBC application to succeed, you'll generally have to demonstrate several things to your council, including the following: The solar panels won't significantly alter or detract from the property's aesthetic qualities.

#### Are solar panels legal in the UK?

All electrical work in the UK must comply with the national standard,BS 7671. Therefore,it's not just about the legality but also the safety and reliability of your solar panel system. While the Feed-in Tariff (FIT) scheme has concluded for new applicants,those already part of it continue to benefit from the incentive.
