

# Is it illegal to rent photovoltaic panels on farmers roofs

How do solar panels help farmers & landowners?

Farmers and landowners can secure financial assistance through solar panel grants covering a portion of the solar equipment costs. This scheme is designed to support the adoption of renewable energy sources and enhance farm productivity.

Do solar farms need planning permission?

Yes, all solar farms need planning permission because of their size. In the UK, any ground mounted solar panel system that is larger than 9 square metres needs planning permission, and most solar farms are several acres. Do solar farms make noise? Solar panels themselves don't make noise, but some of the additional solar equipment does.

Are solar panels paying rent for your roof?

Technically, they're not paying rent for your roof, because you'll get the benefit of powering your home using solar power instead of grid electricity. They'll make money from the electricity you don't use. All excess electricity generated is sold back to the grid via the Smart Export Guarantee (SEG) scheme.

The Rent-a-Roof scheme lets people who can't otherwise afford solar panels gain access to them, through installers who will set up solar panels on roofs for reduced prices. Installers can then sell any excess electricity generated back to the grid.
