### Powin energy storage cabinet caught fire

Did a powin battery storage system catch fire?

What we have learned is that the fire alarms that went off occurred with two of Powin's newest model battery storage systems, which are referred to as the Centipede. One of those Powin Centipede systems, on County Road 1A in Warwick, NY caught fireas of early afternoon on June 27 th, 2023.

#### Is there a fire at a powin site?

There is currently an active fireat one of the sites. The local fire department, team members, and battery storage system manufacturer Powin have representatives on-site actively managing the situation and coordinating the response.

#### What happened at a battery energy storage system?

The governor's announcement came the day after fireerupted at a battery energy storage system in the Town of Lyme,in upstate Jefferson County on July 27. Hochul cited that fire and others at battery energy storage facilities in the Town of Warwick,in Orange County on June 26 and in the Town of East Hampton in Suffolk on May 31.

#### What is a powin stack750 centipede battery system?

Hexagon's Riverhead site plan depicted Powin Stack750 Centipede modular battery system consisting of 448 lithium iron phosphate batteries in 16-battery segments. Southold and Southampton towns this year both enacted moratoria on new battery energy storage systems, to allow officials time to evaluate fire and safety concerns.

#### Where are convergent & powin batteries stored?

"The next couple of days will be used by Convergent and Powin to gather additional information." Powin is the manufacturer of the lithium-ion batteries stored by Convergent inside several storage containers housed on Warwick school grounds. The company rents the property from the school district, according to town officials.

#### How did a battery catch fire at an engineering & test center?

A battery caught fire at an engineering and test center. Firefighters used a grappling hook to open the container's doors, cool the batteries with water, and extinguished the fire after 4 hours. The affected container was pulled away from the other battery containers with a tractor to prevent the flames from spreading.
