How much power does the Comoros use?

First, reliance on imported fossil fuels for power production. In 2018, electricity generation in the Comoros consisted of small-scale diesel generators adding up to a total installed capacity of 31.5 MW: 19.4 megawatt (MW) in Grande Comore, 7.4 MW in Anjouan, and 4.70 MW in Mohéli.

What will comorsol do for Anjouan?

ComorSol would fund the rollout of the same CMS in Anjouan, extend the expired maintenance guarantee of hardware and software for another three years until SONELEC is fully capable of maintaining the system on its own, and add critical additional features and modules such as mobile payment.
