What is a solar charge controller?

A solar charge controller is a critical component in a solar power system, responsible for regulating the voltage and current coming from the solar panels to the batteries. Its primary functions are to protect the batteries from overcharging and over-discharging, ensuring their longevity and efficient operation.

Do solar panels need a PWM charge controller?

PWM (pulse-width modulation) charge controllers depend on older, less reliable hardware and enable you to adjust the solar panel's voltage to the battery voltage. E.g., if you were to run a nominal 12-volt solar panel through a PWM charging controller, you need a 12-volt battery bank.

What is a solar charger?

A solar charger is a charger that employs solar energy to supply electricity to devices or batteries. They are generally portable. Solar chargers can charge lead acid or Ni-Cd battery banks up to 48 V and hundreds of ampere hours (up to 4000 Ah) capacity. Such type of solar charger setups generally use an intelligent charge controller.

How many amps can a solar charge controller handle?

Let's consider a charge controller rated to handle 30 amps of current. The single 100-watt solar panel described above puts out 5.5 amps of current at 18 volts. That amperage is much lower than the charge controller's maximum of 30 amps, so the charge controller can easily handle the output of the singular solar panel.

What is a solar charge and discharge controller?

The diagram below shows the working principle of the most basic solar charge and discharge controller. The system consists of a PV module, battery, controller circuit, and load. Switch 1 and Switch 2 are the charging switch and the discharging switch, respectively.

How do solar chargers work?

Such type of solar charger setups generally use an intelligent charge controller. A series of solar cells are installed in a stationary location (ie: rooftops of homes, base-station locations on the ground etc.) and can be connected to a battery bank to store energy for off-peak usage.

The fundamental working principle of a solar charge controller is centered on its capability to effectively manage and modulate the flow of electrical energy originating from the solar panels before it reaches the battery bank.
