How many carbon credits does a solar power plant receive?

Reduced emissions = (1 MW \*8000 MWh \*500 g CO2e/kWh) 1 MW \*8000 MWh \*0 g CO2e/kWh Conversion Factor: The VCS uses a conversion factor of 1 credit = 1 metric tonne CO2e. Issuance of Carbon Credits: The solar power plant is eligible to receive 4,000 carbon creditsbased on the calculation of emissions reduction and conversion factor.
