

Should solar panels be taxed in Thailand?

Thailand's IEEE Power and Energy Society urges expanding tax incentives for rooftop solar panels to boost clean energy adoption and aid SMEs.

Who can apply for a solar project in Thailand?

To apply, solar producers must be 51% Thai-owned, which "really limits participation to already established (mainly Thai) players or high-risk takers with flexibility in the legal structuring," according to Sticher. Applications will be prescreened according to readiness of land, technology, funding, and project planning.

Does Thailand need a solar PV system?

Thailand's abundance of land with high insolation is likely to result in applications for solar PPAs exceeding yearly targets and potentially creating bottlenecks at Grid interconnection points, however the selection process prevents solar from cutting off access to other technologies.

Who is eligible to buy solar panels in Malaysia?

Householdspurchasing solar panels with a power generation capacity under 10 kilowatts and costing less than 200,000 baht are eligible, as per the Department of Alternative Energy Development and Efficiency.

How much solar capacity does Thailand have?
